WP1: Literacy Narrative 2.0

Description

In your Literacy Narrative, you explained a time when you were new to a space and what things confused you about it at the time. Now, you'll adapt that narrative to a new medium, such as a video, a podcast, a website, a comic, or some other form of media. Try to choose a medium that people new to your community might be likely to use. After you're finished with your adaptation, you'll write a reflection explaining the choices you made when making it. In particular, you'll focus on what changes you made when adapting the narrative, what choices you made to make the new narrative appealing, and how the choices you've made will fit your audience. Please note: The reflection is 50% of your grade for WP1. It's important to do *both* pieces well.

Learning Outcomes

By the end of this writing project, you will be able to:

- Adapt material to meet the needs of a specific audience and rhetorical situation.
- Make rhetorical choices when using different media.
- Recognize established genres and work toward replicating them.
- Employ strategies for revising texts.
- Reflect on rhetorical choices made when adapting writing.

Requirements

Literacy Narrative

All drafts of the new narrative should include *roughly the equivalent content to 800 words of text*. Not all of the communication will be in words, however. It's likely that your narrative will include images, video, sounds, symbols, or other media. All projects must include at least one mode other than written text.

Reflection	Your reflection accounts for 50% of your grade on WP1. The reflection must be at least 800 words . Reflections can also be multimodal and include things like video, images, symbols, or sound.
Submission	Please submit your reflection through OneDrive. If you have posted your Literacy Narrative publicly, you can place a link to it in your reflection document. If not, you can share your Literacy Narrative document in OneDrive as a separate file. Please approve any alternative methods to submit your Literacy Explanation with me in advance.
Naming Documents	Please name your files using the following convention: <p style="text-align: center;">course.section_your name_assignment.draft.</p> For example, a student in ENGL 103 section 08 named Malcolm Reynolds working on WP1 draft 1 would name their file: <p style="text-align: center;">103.08_MalcolmReynolds_wp1.1</p>

Completion Drafts	Completion drafts are graded on demonstrating a basic understanding of the requirements. Grades for completion drafts aren't an indication of how well you'll do on the revision draft. To get full credit for the completion draft, you must do the following:
Choose a genre and format	Choose a genre for your Literacy Narrative that fits the literacy practices you're explaining. The genre is not written text alone. The media in the narrative should be complete or near complete.
Adapt to your narrative	Adapt your narrative. The adaptation should include mostly the same content as your written narrative, but you have adapted it to fit the genre you've chosen and your audience.
Write a reflection	Like with the revision draft, the reflection accounts for 50% of your completion draft. Your reflection should explain your choices of genre and format for the Literacy Narrative as well as any choices you made to help your audience understand. The main goal is to explain <i>why</i> your narrative looks, sounds, and feels like it does.

Revision Drafts

Revision drafts are graded on the criteria below. Each criterion is evaluated as “exceptional,” “met,” or “not met.” If all of the criteria are “exceptional,” you will earn an A. If they are all “met,” you will earn a C. One or more criteria in the “not met” column may result in an F.

Grading Criteria: Reflection	Exceptional	Met	Not Met
1. Reflecting on Your Genre Choices	You have clearly identified choices in your reflection that you made in your narrative that fit the genre you have chosen.	You have mentioned choices in your reflection related to genre conventions.	Genre conventions are not mentioned in the reflection.
2. Reflecting on Your Design Choices	You have clearly identified choices in your reflection that you made in your narrative that explain why you designed your project as you did.	You have mentioned choices in your reflection related to design choices.	Design conventions are not mentioned in the reflection.
3. Reflecting on Appealing to Your Audience	You have identified specific things in your reflection that you have done in your narrative to appeal to your audience or help them understand better.	You have mentioned things in your reflection that you have done in your Literacy Explanation to help your audience.	Audience appeal or adaptation is not mentioned in the reflection.
4. Reflecting on Your Rhetorical Purpose	You clearly explain your goal in making the narrative and explain how you met that goal.	You explain your goal in making your narrative.	The goal of the narrative is not mentioned in the reflection.
5. Responding to Feedback	You have revised your reflection substantially and/or thoughtfully based on both your peers' and your instructor's feedback.	You have revised your reflection based on both your peers' and your instructor's feedback.	No revisions to the reflection have been made or only minor changes have been made that do not adequately respond to feedback.
6. Meeting Requirements	You have met or exceeded all of the requirements for the reflection.	You have met all of the requirements for the reflection.	One or more of the requirements for the reflection has not been met.

Grading Criteria: Narrative	Exceptional	Met	Not Met
1. Adaptation of Narrative	You have adapted your narrative to a new genre and have included new things or removed pieces of narrative to fit that genre.	You have adapted your narrative to a new genre.	The narrative is not adapted or the adaptation includes only text.
2. Meeting Genre Goals	Your narrative fits well within the conventions of the genre as laid out in your reflection. The genre is recognizable.	Your narrative resembles the conventions of the genre as laid out in your reflection.	The narrative does not resemble the conventions of the genre as laid out in the reflection.
3. Use of Media	More than one non-written text mode is used in your narrative. Modes enhance the narrative.	At least one non-written text mode is used in your narrative. It helps to explain the narrative.	The narrative is written text alone or modes are included in ways that do not support the narrative.
4. Adapting to Your Audience	Your narrative is suitable and appealing for your chosen audience. Content has been adapted specifically to appeal to that audience.	Your narrative is suitable for your chosen audience.	The narrative does not suit the audience explained in the reflection.
5. Responding to Feedback	You have revised your narrative substantially and/or thoughtfully based on both your peers' and your instructor's feedback.	You have revised your narrative based on both your peers' and your instructor's feedback.	No revisions to the narrative have been made or only minor changes have been made that do not adequately respond to feedback.
6. Meeting Requirements	You have met or exceeded all of the requirements for the narrative.	You have met all of the requirements for the narrative.	One or more of the requirements for the narrative has not been met.
